#### **II. Committee Reports**

- a. RAC- Char Reavis- The RAC had a lot of participants, due to being able to connect on Zoom and not travel. Each rural area reported on the impact of Covid-19. Most communities are coming together to help. Food pantries and Local Aid groups are getting increased resources.
- b. Prevention- Tara DaVee- Many school-based programs are on pause. Our team has been sharing CATCH activities that are designed for families at home. Positive Behavior Interventions & Supports for schools is already mostly online trainings/coaching so that should be relatively unaffected. QTIP Coordinator is getting creative with coaching clients remotely and sending electronic gift cards
- c. CAP- Rick Kincaid- The CAP discussed the COVID situation and how to better utilize Telemedicine.

#### **III. CCO COVID Response-** Dr. Savage reported on the CCO response to COVID-19, including outreach to providers, provider support, community support and outreach to members.

#### **IV. CCO Reports**

- a. Innovator Agents- Belle Shepherd and Dustin Zimmerman gave an update on OHA's response to Covid
- b. Brian Laing provided the Pacific Source update regarding PacificSource's current response to COVID-19 including transitioning services to telehealth, addressing community needs through grants to community organizations.
- c. Rhonda Busek provided the Lane Community Health Council update regarding Lane Community Health Council's partnership with United Way in providing funding to the Community COVID-19 response. PacificSource continues to work with members to identify resources related to COVID-19.
- d. Debi Farr and Amanda Cob provided the Trillium update. COVID-19 Response- Trillium is helping members transition to Telehealth, have developed a response

plan to address community needs created by COVID-19. PPE, and donations addressing SDOH/Health Equity are being provided to community partners.

- V. Telemedicine Discussion- Dr. Little provided information about the increased use of telemedicine in response to Covid. The CCO's and providers have quickly expanded access to telemedicine. Issues that were raised in the discussion include:
- Concerns about privacy
  - Concerns about adequate access to reliable internet connection
  - May increase access to care for certain populations, such as those with disabilities and those living in rural communities.
