



## Lane County Community Advisory Council Notes Summary - July 28, 2025

#### I. Welcome and Introductions

- Michelle welcomed everyone to the meeting.
- Kayla shared information about the Health Equity Committee meeting on August 12 and introduced two new CAC staff members with Lane County Public Health:
  - Teresa Roark Health Promotion and Prevention Strategist
  - o Del Borden Jr. Community Health Analyst
- Tannya led a calming breathing exercise.
- There were no public comments.

# II. Remembering Drake Ewbank

 Drake Ewbank, a CAC member, passed away. Members shared kind words about Drake's work in the community and described him as a behavioral health advocate. He used to lead SAFE, a treatment center in Springfield. Kayla asked members to share ideas on how to honor him.

- June 23 Meeting Notes: The group approved the notes from the June 23<sup>rd</sup> meeting.
- CAC Quarterly Summary (April–June 2025)
  - Kayla shared photos and updates from community events.
  - o The CAC and Youth Health Council will meet in September.
  - A new Community Health Improvement Coalition (CHIC) was formed with 10 CAC members.
  - Members also attended a webinar on Indigenous Social Determinants of Health.
  - The group approved the quarterly summary to be sent to the CCO boards and Clinical Advisory Panels.

# V. Community Health Improvement Plan (CHP) Report & Community Health Assessment Update

- Leilani shared slides about the 2021–2025 CHP report.
  - Final report will be sent to OHA by the end of 2025.
  - The report includes disaster response, community resilience, and collaboration with 20+ partners.
  - The group approved the CHP Progress Report.
- Jennifer shared the 2024 Community Assessment Statements and asked for questions—none were shared.
- Olatorera encouraged members to reflect and give feedback on the Community Health Assessment Process (see handout).

## V. Legislative Session Update & Future Planning

- Courtney shared:
  - $_{\circ}$   $\,$  Oregon Medicaid and Healthier Oregon are fully funded through 2026.
  - New laws passed to support behavioral health, doulas, and community health workers.
- Kellie DeVore shared:
  - o A special session will focus on transportation funding.
  - Federal changes to Medicaid could be coming and are being monitored.
- Questions from CAC members for the September Meeting with the Legislative Liaisons:
  - Members wanted updates on:
    - Health-Related Social Needs (HRSN) funding and future changes.

- If federal funds might be pulled back.
- How transportation cuts could affect rural and coastal health services.
- Details about the new six-month eligibility process for health benefits.
- More information on waivers for continuous eligibility.
- o Ideas: More use of Uber/Lyft, teaching people how to ride the bus.
- Opportunity: A transportation meeting will happen August 21 in Cottage Grove (see invitation).

## VI. Updates & Calls to Action

- CAC Member Openings
  - Kayla said there are three open member positions representing PacificSource
    OHP, plus the RISE partner position.
  - Recruitment is open now with interviews expected in August or September.
  - o Outreach materials are available in Spanish and English.
  - Youth, alternative medicine users, and people from Oakridge/McKenzie
    Bridge were named as outreach priority areas.
- Intertribal Connection Updates
  - Jessica shared feedback from the June 5<sup>th</sup> Health and Wellness Carnival hosted by the Confederated Tribes of Siletz Indians Eugene Area Office.
  - Feedback was positive and touched upon the following:
    - Variety of foods, accommodated Gluten Free
    - Welcoming and friendly
    - Abundant Children's activities
    - Diverse and Innovative Information Tables
  - Jessica announced that they are working to move into a new Eugene office and CAC members would be invited when opened.
